

Purchasing policy 2019/2020

Who are we!

We are Quality and Purchasing department of the Bastion Hotels. We take care of purchasing, quality control and policy-making regarding purchasing over 30+ hotels in the Netherlands and 1 in Germany.

The Bastion Hotels strives for a sustainable purchasing policy. As a hotel group, we can make large and targeted purchases. Because of this strength, we can stimulate the market to seek more innovative and sustainable products. We always investigate the possibility of fair trade, bio-certified and / or regional products. In the choices regarding the purchase of products, we take into account the possible influence on the environment and on the environment. Here we look at each product and service itself, so the choice of suppliers and products is based on what is best for the environment and the environment.

Policy

As part of our CSR policy to make our environment a healthier and better residential and work climate, we strive to buy products and materials be certified with an eco-label or that are fair-trade, recyclable, bio-certified, energy-efficient or regional. We try to limit our waste as much as possible by separating multiple waste fractions. We expect our largest suppliers to comply with a recognized sustainability mark or demonstrate a demonstrably sustainable sustainability policy with equivalent to recognized sustainability labels. We prefer suppliers who have a sustainability policy and supply durable goods.

Bastion Hotels requests from the suppliers, as part of the purchasing policy, a return system, by asking them to supply reusable packaging and containers / pallets and to take them back again, and to work with a deposit on bottles and boxes. We prefer products in bulk packaging and we ask suppliers to replace individually packed, waste products for bulk packaging where possible. We mainly work with crates and roll containers (return supplier) and soft drink bottles with deposit money.

Target

The goal is to map guidelines that promote the purchase of sustainable products and stimulate services without compromising the performance of Bastion Hotels. When purchasing products, long-term savings are considered, in contrast to short-term cost savings. We recognize that waste can be reduced by using reusable products and compostable and recyclable materials.

By buying responsible products we contribute to the creation of a pesticide-free world, and through the purchase of bulk parties, we strive to reduce the CO2 emissions caused by transport.

To support this initiative, Bastion Hotels, as an integral part of the purchasing process, will ask suppliers to indicate when there is an alternative product on the market that is fair trade or eco-certified. We also ask for smart methods to create fewer transport moments, thus reducing CO 2 emissions.

Purchasing guidelines

- Selecting less environmentally harmful and socially responsible F & B products
- Reducing the use of environmentally harmful components.

This is done by using as much as possible:

- Give preference to local suppliers, suppliers who deliver durable goods or suppliers with whom a sustainability declaration has been signed. By signing the sustainability declaration, the supplier indicates that he is committed to corporate responsibility and sustainable cooperation.
- Inform about sustainable building materials during new construction, renovation and / or renovation.
- Ensure less harmful production processes by purchasing less environmentally damaging paper with an eco-label.
- Preferably apply energy-saving measures by purchasing energy-efficient lighting, such as LED, PL, TL and energy-saving lamps (as opposed to halogen and incandescent lamps).
- When purchasing new equipment, preference is given to energy-efficient and water-saving equipment.

By products that are less harmful to the environment or socially responsible products are understood products with recognized certifications such as:

- EKO, European organic quality mark
- Label rouge
- Fair trade, Max Havelaar
- UTZ, Rainforest Alliance
- MSC (Marine Stewardship Council)
- ASC (Agriculture Stewardship Council)
- USDA Organic,
- Soil Association
- Krav, Bio-guarantee label
- Bio-Siegel, Demeter
- Eco-label,
- European Ecolabel
- Biologique (AB)
- Agriculture Biologique
- This also includes regional products.
